# CISCO INTRODUCTION TO CYBERSECURITY LEARNATHON Official Rules

This Contest (the "Contest") opens on October 23, 2023, at 12:00 A.M. Pacific Time and ends on November 19, 2023, at 11:59 P.M. Pacific Time, or if earlier, until there are no more available prizes (the "Contest Period"). Entry into this Contest is acceptance of these Official Rules. This Contest is sponsored by Cisco Systems, Inc., 170 West Tasman Drive, San Jose, CA 95134 USA ("Sponsor" or "Cisco").

## 1. ELIGIBILITY.

This Contest is open to participants ("Participants" or "you") who are legal residents of the European Union, United Kingdom, Ukraine, Norway, Switzerland, Serbia, Montenegro, Albania, Bosnia Herzegovina, North Macedonia or Israel and age 18 years or older at the time of entry. This Contest is not open to: (1) employees or internally contracted vendors of Sponsor or its parent/subsidiaries, agents and affiliates; (2) the immediate family members or members of the same household of any such employee or vendor; (3) anyone professionally involved in the development or administration of this Contest; (4) employees or internally contracted vendors of governments and government-affiliated companies or organizations; or (5) any employee whose employer's guidelines or regulations do not allow entry in the Contest or acceptance of the prize(s).

## Learn-A-Thon:

- Host a 4-week event at your Cisco Academy.
- Create a self-paced Introduction to Cybersecurity class **on the skillsforall.com** platform. Instructor must use the start date of October 23, 2023, and use the following naming convention when setting up the course: Learnathon2023\_#EuropeanCyberCup\_<Instructor Last Name>
- Register your class on the Learn-A-Thon website to participate; At registration, you must provide the
  correct course name and class ID. The class ID is the self-enroll link or course URL link from the Invite
  Learners tab once the course has been created. We will use the course name and class ID to track your
  student participants. Qualifying student participants are students that launch, interact, and complete
  course activities.
- Enroll students and/or share the link to the self-paced Introduction to Cybersecurity Course on skillsforall.com. Please encourage students to complete the course and earn the Introduction to Cybersecurity digital badge. All students who complete and pass the Introduction to Cybersecurity Course with a 70% or higher will earn a digital badge to share on social media platforms.
- A total of twenty (20) prizes will be awarded. The top 20 instructors with the most student participants will win prizes. Only one prize per instructor will be awarded.
- The top sixteen (16) academies participating with the highest points will qualify to play and be invited to participate in the European CyberCup Capture the Flag. These top 16 academies will select a team of four (4) students to represent their academy and compete head-to-head in the European CyberCup Capture the Flag that launches on December 1, 2023. The point system will be the sum of the points collected in the following categories calculated as follows:
  - o 2 points multiplied by the number of student participants (students that launch, interact, and complete course activities)

- o 3 points multiplied by the number of skilled students (students that complete any Quiz/Final exam (with a score of 70% or higher) OR complete the Course Feedback Survey)
- 4 points multiplied by the number of badge qualified students (Students that complete the Final Exam with a score of 70% (any attempt) or greater AND completes all questions on the Course Feedback Survey)
- The **Top Three** (3) **Performing Partners**: the top three (3) Academy Support Centers (ASCs) identified at registration by any participating Learn-A-Thon instructor will be entered to win one of the three top performing partner awards. The top three ASCs with the highest points collected using the following category calculations are as follows:
  - Academies active the last twelve (12) months will be calculated for their Academy European CyberCup participation rate
  - Points assigned based on the sum of the total student participants (qualifying student participants are students that launch, interact, and complete course activities) for the European CyberCup Learn-A-Thon competition
  - Points assigned based on the sum of the total of the new academies who joined the Cisco Networking Academy during the European CyberCup Learn-A-Thon competition

The twenty winners will be the top instructors with the most student participants in the Introduction to Cybersecurity classes on www.skillsforall.com. The top twenty (20) instructor winners will be notified by November 24, 2023, by 11:59 P.M. Pacific Time (US).

In the event of a tie, the instructor that achieved the most student participants in the earliest time will be awarded the prize. Only one prize per instructor will be awarded.

## Top 16 Academies:

Cisco will run reports to calculate the participating academies in the Introduction to Cybersecurity courses on www.skillsforall.com that were registered for the Learn-A-Thon. The sixteen (16) academies with highest points will be calculated using the sum of a point system in the following categories:

- o 2 points multiplied by number of student participants
- o 3 points multiplied by number of skilled students
- o 4 points multiplied by number of badge qualified students

The top sixteen (16) qualified academies for European CyberCup will be notified by November 24, 2023, by 11:59 P.M. Pacific Time (US).

In the event of a tie, the academies that achieved the highest score in the point system above in the earliest time will be awarded the prize. Only one prize per academy will be awarded.

Cisco will run reports to calculate the Academy participation rates, number of student participants enrolled and the number of new academies who joined and are participating in the European CyberCup Learn-A-Thon competition. The top three ASCs with the highest points collected using the following category calculations are as follows:

- Academies active the last twelve (12) months will be calculated for their Academy European CyberCup participation rate using the following point system:
  - o 0% to 10% participation rate: 50 points
  - o 11% to 20% participation rate: 100 points
  - o 21% to 40% participation rate: 200 points
  - o 41% to 60% participation rate: 400 points
  - o 61% to 80% participation rate: 800 points
  - o 81% to 100% participation rate: 1000 points
- Points assigned based on the sum of the total student participants for the European CyberCup Learn-A-Thon competition (1 point per student participant)

Cisco will run reports to calculate the number of student participants enrolled in the Introduction to Cybersecurity courses that were registered for the Learn-A-Thon. The top Partner Innovation award will be judged by analysis of the project and its impact by a three-person committee from the Cisco leadership team.

The top Innovative Partner will be notified by December 15, 2023, by 11:59 P.M. Pacific Time (US).
